編輯說明

- 一、本局於民國 49 年 2 月 16 日奉令改制,由林產管理局更改為林務局,附屬機構亦由原有之臺北、新竹、臺中、臺南、高雄、臺東、花蓮等 7 個山林管理所及阿里山、太平山、八仙山、竹東、巒大山、太魯閣、木瓜山等 7 個林場,重新區劃歸併為文山、竹東、大甲、埔里、巒大、玉山、楠濃、恆春、關山、玉里、木瓜、蘭陽、大雪山等 13 個林區管理處。其中大雪山示範林區管理處原係大雪山林業公司直隸臺灣地區政府,自 63 年 1 月 裁撤併入本局。民國 78 年 7 月 1 日本局由事業機關奉令改制為公務機關,由原有之 13 個林區管理處裁併為現制之羅東、新竹、東勢、南投、嘉義、屏東、臺東、花蓮等 8 個林區管理處;另為森林資源調查及基本圖之測製,設一農林航空測量所。民國 88 年本局配合省府組織調整,改隸行政院農業委員會。
- 二、本刊共11章:(一)森林資源、(二)造林、(三)保林、(四)防砂治水及林道、 (五)自然保育、(六)社區林業、(七)林產處分、(八)森林遊樂、(九)森林鐵 路、(十)木材供銷、(十一)員工人數。
- 三、本刊各表有以區域分項者,羅東林區管理處、新竹林區管理處、新北市、台北市、桃園市、宜蘭縣、新竹縣、基隆市、新竹市、連江縣、森林保育處、林業試驗所併為北部。東勢林區管理處、南投林區管理處、台中市、苗栗縣、彰化縣、南投縣、雲林縣、金門縣、台灣大學實驗林管理處、中興大學實驗林管理處、台灣大學附設山地實驗農場併為中部。嘉義林區管理處、屏東林區管理處、台南市、高雄市、嘉義縣、屏東縣、澎湖縣、嘉義市、嘉南農田水利會併為南部。台東林區管理處、花蓮林區管理處、台東縣、花蓮縣併為東部。

- 五、本刊各表動態資料係以1月1日至12月31日為起訖日期,靜態資料係以12月31日為準。

INTRODUCTORY NOTES

- 1. The Forestry Bureau was reorganized in Feb. 16, 1960 from Taiwan Forest Administration. Its dependent organizations originally include seven district offices, namely Taipei, Hsinchu, Taichung, Tainan, Kaohsiung, Taitung, and Hualien together with seven Logging Stations, such as Alishan, Taipingshan, Basianshan, Jhudong, Luanta, Taroko and Mukuashan, which were reorganized and mingled with the above mentioned seven forest district offices into 13 forest districts namely Wunshan, Jhudong, Dajia, Puli, Luanta, Yushan, Nannung, Hengchun, Guanshan, Yuli, Mukua, Lanyang and Dasyueshan. Of these 13 forest districts, in 1974, Dasyueshan Demonstration Forest District was cut down and merge into F.B.. The Forestry Bureau has become a government budgeted administrative agency since July 1, 1989. The original 13 forest districts were reorganized into current 8 forest district offices named Luodong, Hsinchu, Dongshih, Nantou, Chiayi, Pingtung, Taitung and Hualien. For forest resources survey and aerial photogrammetry, this bureau, has set up the Aerial Survey Office. Following the promulgation of the Provisional Statute for the Reorganization of Taiwan Provincial Government, on July 1, 1999 the Bureau was placed under the central government as the Forestry Bureau of the Council of Agriculture, Executive Yuan.
